Student Concerns Update

Listed here are four macro-level student concerns (not in any particular order), solicited from various meetings in January. In each corresponding box, I have noted our updates in terms our intentions here in the DOS office.

In regards to the growing concern of hate speech and free speech, I would like to share the words of Chancellor Leland from a recent letter: "As a university and as individuals, we are obligated to stand up against hate and to resist it in whatever form it presents itself. But as a public university, we must also uphold the First Amendment to the Constitution, which prohibits governmental entities — including public universities and colleges — from regulating expression on a vast variety of matters and settings ... We can counter such speech with protests and boycotts and robust denunciations, and we can exercise some contentneutral time, place and manner restrictions. But we cannot legally suppress it solely because it is hateful." I encourage members of the campus community to attend a presentation on February 13th from 4:30-5:30pm in COB2 110 with Dean of Berkeley Law Erwin Chemerinsky to learn more about free speech.

Meetings

During the month of January, multiple large scale meetings occurred.

- The DOS Advisory Board met with the UC Student Regent Paul Monge and shared with him many concerns the campus is facing. The UC Student Regent was very kind and offered his own feedback and support regarding some of the concerns aired.
- Dr. Grady and myself met with the Intercultural Hub Board to discuss ideas regarding cultural spaces.

Effective communication on our campus is critical for student affairs particularly. With stellar communication comes trust, and with trust, students and administrators can push work forward.
